#### **Unfinished Business:**

- a. Grant Application After Action Work Completed
  - i. Over 40 volunteers over the 2 days of work offering over 480 hours of time.
  - ii. Anticipated 45 ton of rock and 1100' x 400' of weed barrier would be needed. Needed an additional 15 ton of rock and 4 additional rolls of weed barrier.
  - iii. For next year's grant: Need to extend time for lane closures and reduce the distance of the work to be completed.
  - iv. A Mission Viejo resident will pull gift card winners at October board meeting.
  - v. All work complete. Day 3 of work no longer needed.
- b. Dumpster Day (October 3) Final Preparation
  - i. Trucks have been ordered.
  - ii. Alan will have the latest list from Pro Disposal to see who is a paying member. We will also add to the list everyone who has volunteered or paid HOA dues so we will be able to check if a resident does not have their member card.
  - iii. Cash or check only for any members or non-members intending to use the dumpsters and pay on the day.
  - iv. Enter through Chambers Way and exit on Marguerite. Watch for people directing traffic.
  - v. No electronics, appliances, chemicals, rocks, or cement.

- vi. Reminder, if you currently use Pro Disposal, have paid \$30 to the HOA in 2015, or volunteered in 2015, the dumpster will be free to use. You can pay \$30 on that day to become a member or non-members can pay \$35 after 10:30 to use the dumpster.
