- 5. Committee Reports (Welcome, Garden Club, July 4th, Business Liaison & others)
 - a. Garden Club
 - i. Garden looks well, getting people together to weed
 - ii. Advertisement is currently on the website—want description to display in the newsletter
 - iii. Submit requests for supplies to board (e.g. plants)
 - iv. Troy has flagstone available
 - b. 4th of July
 - i. Food is set

- ii. Line sidewalks with flags again (in storage—few were taken)
 - 1. Put out by the Garden Club
 - 2. Need more skewers
- iii. Band is set but need a contract
- iv. Rent a popcorn machine (1000lbs donated) and dunk tank
 - 1. Buckley Air Force Base?

- 6. Unfinished Business Agenda
 - a. Elaine Lay request to serve on the board
 - i. As of today, the board is full (addition of Kerri and Travis).
 - ii. The board appreciates the offer to serve on the board and what she does in the community
 - iii. Elaine wants to be involved with getting people to participate in events and help the community.
 - 1. Neighborhood Clean Up on May 3- 25 volunteers to clean up on Hampden for a few hours
 - a. Post notes and contact people from previous cleanups to help
 - b. Request plants for Hampden
 - c. Would like to coordinate volunteers (mainly clean ups but could also help with 4th of July)
 - Motion from Jeremiah for Elaine to be the event coordinator, Troy seconds, discussion—city now charges \$600 to close down lane for 4 hours + a \$250 permit, passed unanimously
 - i. Inexpensive under 3 hours-- can notify city and contact company to put down cones
 - ii. Had a water line down Chambers and Hampden, but there were leaks that ended up costing a lot of money. Need to look at water line for leaks before purchasing plants.
 - iii. Elaine would like to work on Hampden
 - iv. \$100 to close 150ft, additional charge for more feet
 - v. Cannot happen for this clean up but revisit in the future
 - b. D & O Liability Insurance Policy
 - i. Received bill in the mail last year:\$1827 this year: \$2500+
 - 1. Charged for 3 special events (4th of July, Music in the Park, and Holiday Hayride)
 - a. Each special event is \$300
 - b. Do we need insurance for all events?
 - 4th of July is the only event that is not covered by another company or building
 - c. Has contacted Auto Owners insurance about special events
 - d. Jeremiah makes a motion accept just having the 4th of July on D&O Insurance, seconded by Troy, passes unanimously

7. New Business

- a. New Ting Device Testing
 - i. Last month decided to purchase last mifi device
 - ii. Was order- on financial statement
 - iii. Was suppose to be in today, but it did not arrive.
 - iv. Jeremiah and Alan will try it sometime in the future
- b. Proposed Closure of Access between S. Nucla Way and King Soopers shopping Area Informational
 - i. Final phases of design- within 90 days a fence will be erected to close access
 - ii. That part of the street is part of the 100 year flood plan—must be clearance for water to flow underneath
 - iii. Property management got approval to cut down trees for visibility purposes (1 bush gone)
- c. Spring Clean-up
 - i. May 3
 - ii. Meet at Holy Love Church (cross side) at 8:00AM, leave at 8:15AM, out at 12:00PM
 - iii. General cleaning with focus on drainage area by park
 - iv. Safety vests for those cleaning up on Hampden
- d. Community Garage Sale
 - i. Scheduled for June 6-7
 - ii. Alan is working with Todd to make sure it is advertised and signs come out.
 - iii. Contact GoodWill/Salvation Army and Dalene to pick-up left over items
- e. Ironwood Weeding
 - i. Paid today (prepayment had to be paid by the day of the first spraying)
 - ii. Paid for trees to come down off of Hampden at the end of last year—issues with city are resolved trees can be removed
 - iii. Notify Alan if weeds are not dead from current spray—will redo for no additional cost within 20 days
- f. Amendment 64 Bob Roth asked us to comment on our thoughts on how we are going to handle this, how we should handle it or is it a City Issue. (Via Dala)
 - i. Alan responded that it is a city issue not an HOA issue. If they want to make it a HOA issue, the HOA will push back requesting money to change each filing 2000 + homes @ \$10.00/home.
 HOA will not get in the way of the city rules—it is not a covenant issue.
- g. Hand-railing City replaced last year on a green belt between 3600 Joplin St. and Kalispel St.
 - i. Replaced places and did not replace handrails.
 - ii. Bob Broom pushed for handrail to be replaced.
 - iii. City will be putting handrail up in that area.
- 8. City of Aurora Project Plan Reviews
 - a. Signs up do street sweeping—cars must be out of the street for 24 hours to clean
 - b. Tree trimming since November—city trees cut down within 5' of the sidewalk (must have certain canopy height from side walk and other side of the street)
 - i. Will trim every city tree every 10 years
 - c. Letter of construction notice—annual water line construction
 - i. Over the next 30 days between 7AM-4:30PM they will be doing work for 4-6 hours
 - ii. Water quality may be comprised during the construction
 - iii. Vehicles must be removed
 - iv. If vehicles are not removed before 7AM, vehicle will be towed at the owners expense
